# SPECIAL INTEREST CONCESSION

## HISTORIC, VETERAN, VINTAGE, & STREET ROD (SIVE)

### The Concession

#### Eligibility

#### Customer

#### Vehicles

The types of vehicles eligible to participate in the SIVE scheme include both Right Hand Drive (RHD) and Left Hand Drive (LHD).

Vehicles that fall into one of the following categories:-

- Classic/Historic vehicles at least 30 years old including tractors.
- Vintage vehicles manufactured 1 January 1919 and 31 December 1930.
- Veteran vehicles manufactured before 1919.
- Historic Ambulances and Fire-Fighting Equipment (These vehicles are not subject to the minimum 30 years age restriction that applies to other Historical, Veteran and Vintage vehicles. These can be younger superseded units that are being maintained in near working condition for historical reasons).
- Street Rod (Hot Rods) vehicles original body & frame built before 1949, or is a replica that has been modified for safe roads use and is fitted with a modification plate code LH9 concessional registration. (LH10 code is for open registration and is not entitled to a concession).

#### Club Membership

- Evidence of current membership of the club or association should be provided at the time of application for the concession.
- Registered operators are expected to retain current membership of a properly constituted car club or association.
- The club membership condition may be waived by the Policy Officer, Vehicle Management Unit Dating Certificate.
- Vehicle must be inspected by a club official of a properly constituted car club or association to certify that it was manufactured not less than 30 years ago.
  - ❖ Verifying year of manufacture
  - ❖ If the club official or dating officer can verify the year of manufacture through the frame or engine number, Queensland Transport will accept his certification. The club official or dating officer must determine which of the two identifiers is the most authentic.
- Certificate must be in club letterhead or official club documentation and presented when applying for concessional registration.

### Conditions

#### Use of the Vehicle

The use of the vehicle is restricted to:

- Participating in rallies organised by properly constituted car clubs.
- Participating in processions for which a Special Event permit has been issued under Transport Operations (Roads Use Management) Regulation 1995.
- Exhibiting the vehicle in displays, fetes, or similar functions conducted for religious, charitable or educational purposes.
- Use for ceremonial purposes in weddings or school formals involving immediate family members provided this is not done for a fee or reward.
  - ❖ Note:- Immediate family means relationships like those that exist between parents or carers and their dependents and generally does not refer to extended family relations (e.g. nephews, nieces, uncles and aunts)
- Preparing for, proceeding to and returning from the above activities.
- Road testing within a 15 kilometres radius from the place where the vehicle is garaged.
- Travel in order to have the vehicle repaired. There is no distance restriction in these circumstances. However, such travel must be reasonable and openly justifiable by the driver.
- In addition (for street rods/hot rods only) participating in events sanctioned by the Australian Street Rod Federation and events organised by other properly constituted car club.
  - ❖ Note:- If a SIVE concession vehicle is being used for any other purpose, the registered operator needs to either
    - Upgrade to full registration
    - Carry a letter of authorisation for that particular use from Queensland Transport e.g. Responsibilities of CSC operator Lighting.
    - Where a vehicle does not have permanent lighting then registered operator must carry a removable lighting system with the vehicle at all times, and use that system wherever lighting would normally be required.
    - Carbide lights are acceptable when that type of light was originally fitted.

#### Left Hand Drives Modification (Street Rods)

If a vehicle previously modified for concessional registration (LH9) is to be changed to LH10 (open registration), provided there has been no change of registered operation, the vehicle must be presented for inspection to verify that a modification plate for LH10 is attached.

If a vehicle is to be converted from LH10 (open registration) to LH9 (concessional registration), the registered operator must produce a

letter from the Australian Street Rod Federation stating that no modifications have been carried out and the original LH9 plate is still valid.

- ❖ Note:- LH10 code is for open registration and is not entitled to a concession.

### **Transfer**

#### Plates

Special Interest plates or Personalised/Customised plates are attached to vehicles with Sive concession.

If your centre does not have these plates, a SIVE number plate will need to be allocated through Business & Systems Support.

#### Motor Vehicles

- Standard sized Special Interest MV plate in the format S12345
- Square Historic MV Plate that has the format HS1234 (likely to be requested for early vehicles that cannot easily fit standard size plates).
- Customised White on Black standard vehicles plates that are either:
  - ✓ Already fitted to the vehicle under existing registration.
  - ✓ That have been reissued.
- Personalised plates but NOT customised green on white standard format plates.

- SIVE plates in the form S12345
- Customised White on Black standard plates that were either
  - ✓ Already attached to the vehicle under existing registration.
  - ✓ That have been reissued.
- Plates that cannot be issued to SIVE Concession Vehicles.
- When Special Interest Plates are to be removed.
- When the concession will take effect.
